## Impact and Results

We designed and developed three new portals and implemented AI to create an efficient Prescription Management and Labelling System.



#### Portals 1, 2, 3

Patient Portal:

Patient's can...

- 1. Choose a date, time and location for medication delivery.
- 2. Access relevant information and materials about their medication.
- 3. Assist in managing appropriate stock levels.



#### **NHS Portal:**

NHS Trusts can...

- 1. View each patients status including prescription and scheduled deliveries.
- 2. Rapidly resolve queries
- 3. Oversee efficient Invoice Management



#### **Nursing Provider Portal:**

Nursing Provider can...

- Receive efficient and fast referral of new patients
- 2. Provision of Referral forms and prescriptions sent electronically
- 3. Effectively deliver against KPI's



Introduction of E Sign in collaboration with Portsmouth Hospital University NHS Trust <sup>1</sup>...

- 1. The average time from prescription signing to receipt at PHP decreased from 11.18 days to 1.9 days
- 2. The proportion of prescriptions received within 1 working day increased from approximately 3.5% to 59% streamlining the medication dispensing process.

Our Al-driven Prescription Management System has enabled...

- 1. Automated prescription scanning and data extraction
- 2. Reduce prescription processing delays, ensuring timely medicine delivery
- 3. Increased interoperability between the NHS and PHP, Improve query resolution times and Patient Safety
- 4. Enhance governance and auditing of dispensing errors
- 5. Moving to paperless Prescription management Net zero targets.

- NHS is undergoing significant change
  - Analogue to digital

- It is estimated 6.8 million people are living with health conditions that could be appropriate for Clinical Homecare<sup>2</sup>.
